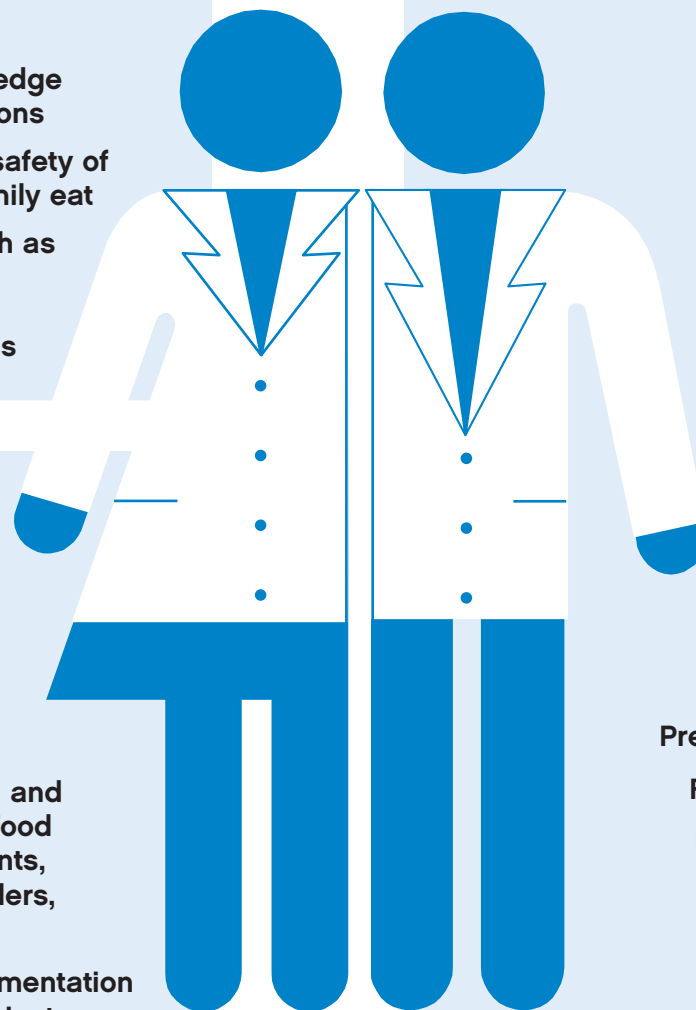

A FOOD SYSTEMS AUDITOR:

Assesses food safety and quality systems developed and implemented by growers, food processors, packaging plants, distribution company, retailers, or foodservice operations.

Verifies the effective implementation of food safety systems against a recognized standard or set of criteria.

Objectively records their findings.

Applies knowledge of food regulations, food industry systems, and food safety, as well as technical knowledge such as food microbiology, HACCP, and food science.
